- ...met the \$2 million matching goal from the Lilly Endowment Inc. which is helping the Foundation provide an additional \$188,000 annually in grants to support our community.
- ...awarded nearly \$330,000 in scholarships to help more than 100 students pursue their dreams by continuing their education.
- ...worked with more than 220 donors individuals, businesses, nonprofits, families and others to build the charitable resources available to our community and to establish permanent funds that will honor the charitable intent of each fundholder.
- ...assisted elected officials in Floyd County to establish the Floyd County Fund, which will permanently put the proceeds from the sale of Floyd Memorial Hospital to work for the community, ensuring a steady stream of reliable income is generated for Floyd County.

\$269,000 IN GRANTS FROM THE COMMUNITY IMPACT FUND

Education plays a role in many aspects of an individual's growth and a community's well-being. According to the Foundation's 2015 Assessment of Needs and Priorities in Clark and Floyd Counties, improvements in education can put a range of positive feedback loops in motion across all areas of our community, including the economy and healthful living as well as our arts and culture.

In 2016, the Community Foundation awarded a catalyst grant for the Student Wellness Clinics at Greater Clark County Schools.

The Student Wellness Clinics provide care to students across all ages in Greater Clark County Schools and are designed to keep kids in school – helping them gain the learning experiences needed to progress further with their academic careers and become successful and responsible citizens.

Health services coordinator for Greater Clark County Schools, Teresa Stengel, said "After our first year of operating the Student Health Clinic at both Jeffersonville and Charlestown High Schools, we found that approximately 32% of our students report not having a family care physician. Because of this, instead of addressing an illness when symptoms first present, many of our students' treatable illnesses deteriorated to the point they were missing a more significant amount school." She continued, "Thanks to this program, our attendance rates are improving because our students are able to remain healthier. When they start feeling ill, a student is able to meet directly with a nurse practitioner free of charge, receive the care needed to treat their illness, and return to class as soon as possible. Simply put, it's helping kids stay in the classroom."

The Floyd County Fund and The Power OF ENDOWMENT

In the spring of 2016, Baptist Health entered into an agreement to acquire Floyd Memorial Hospital, creating a once in a lifetime opportunity for the residents of Floyd County. Floyd County's hospital, which had provided healthcare for those throughout our community, was giving back once again.

After months of study, Floyd County leaders decided that a portion of the proceeds from the sale of Floyd Memorial should be protected from immediate spending and used to provide a reliable source of revenue that today's residents will benefit from while still providing for the needs of future generations. In November, the County used \$70 million of the proceeds to establish the Floyd County Fund at the Community Foundation.


Like all of the Foundation's endowment funds, the Floyd County Fund is a permanent fund which has been invested with the objective of maximizing the return for the County while protecting the principal so it can continue to provide reliable, sustainable resources for the county's needs every year, forever. Most endowment funds are used to build enduring charitable resources that provide support to the causes most important to the individual fundholder, but the Floyd County Fund was created by a governmental unit, and therefore the Foundation will actually provide a grant back to the County each year that elected officials can then use to address the needs they feel are most important to the County and its residents.

Year after year, the residents of Floyd County will benefit from the establishment of the Floyd County Fund. Annually, the Fund will provide millions of dollars of support to the County. This could mean new parks, roads, bridges, safety personnel and equipment, resources for children and the needy or a host of other things. Whatever the future brings, through its endowment with the Community Foundation of Southern Indiana, Floyd County has put in place a mechanism that will allow it to continue providing support for all of Floyd County, for generations to come.

Endowment Funds - An Investment in the Future

When a donor creates an endowment fund with the Community Foundation of Southern Indiana, they are making the choice to invest in the future. Endowment funds are incredible tools used by individuals, families, businesses and other organizations that allow them to support their favorite charitable causes, forever. When your gift establishes an endowment fund at the Community Foundation your charitable causes receive a grant in your name, each year, forever. The fund balance remains invested with the objective to ensure that sufficient funds are available each year to support your original intent.

Using Research To Move The NEEDLE

In 2015, the Community Foundation of Southern Indiana released the 2015 Assessment of Needs and Priorities in Clark and Floyd Counties. Having this comprehensive needs assessment revealed who we are as a community and the role the Community Foundation can have within it.

Now we know how we can create positive growth – by focusing on the areas of basic human needs, education, workforce development, healthful living, economy and arts and culture – and where to invest our grants to provide the most impact for our community.

This past year, organizations addressing our community's needs received more than \$269,000 in grants from the Community Foundation of Southern Indiana's Community Impact Fund which provides support for the greatest needs of our community. New Roots, a local organization, was one of those deserving organizations. According to the Needs Assessment, more than 26,000 people in Clark and Floyd Counties are food insecure, including 9,140 children - New Roots is working to address that need. Karyn Moskowitz,

the organization's founder and executive director said, "We work with fresh food insecure communities to create sustainable systems for accessing the farm-fresh food we all need to be healthy and happy."

Because of the support from the Community Foundation, New Roots was able to establish a weekly Fresh Stop Market in New Albany, serving 150 Southern Indiana families. Like their other sliding scale pop up markets, New Roots' New Albany Fresh Stop Market connects families facing limited resources (and others who pay more into the pool) to over 50 farmers so they can access farm-fresh food right in their neighborhood, every other week. Since these Markets are co-created and sustained by individuals from the community, this helps provide leadership opportunities to individuals and families with limited resources and a passion for food justice, as well as access to affordable, organic, farm-fresh healthy food.

The Community Foundation is using the 2015 Assessment of Needs and Priorities to identify our greatest needs and supporting organizations, like New Roots, who are working to address those needs.

Ms. Moskowitz said, "No matter what your income level or what you can afford to pay, everyone gets the same amount of fresh, healthy and local produce. Nobody is turned away."

The Community Foundation of Southern Indiana provides leadership on important community issues and partners with many other organizations in Southern Indiana to help build a stronger community. Education Matters Southern Indiana (EMSI)

This program was first established in 2013 to strengthen our workforce and improve the economic advantages of our region by increasing the educational attainment of those adults with some form of post-secondary education but no degree or certification. The program reaches across five counties and continues to grow. Last year, EMSI helped 86 people return to complete an associate's or bachelor's degree, or professional certification.

The Community Foundation's Youth Philanthropy Council (YPC) program is designed to encourage youth to give and serve in their communities, making philanthropy a habit for future generations. Annually, a new group of bright, energetic and engaged young leaders learn about philanthropy, complete community service projects, and award grants.

In addition to the \$9,500 awarded in grants to 10 organizations, in 2016 the YPC organized an effort to put Little Free Libraries in New Albany and Jeffersonville. The group partnered with the Arts Council of Southern Indiana, to ensure people throughout our community had access to books for all reading levels. The YPC raised money, collected books and added to our community's proud culture.

Ways to Give

Each citizen in our community has unique interests and ideas for how to give back. Whatever your goals, whatever your means, whatever your passions, the Community Foundation can help you create a customized charitable fund to realize your dreams. Do you want to help students attend college? Would you like your children and grandchildren to one day help determine the charitable organizations that benefit from your fund? Are there specific nonprofits—perhaps your alma mater or place of worship—that should always benefit from a fund you create? Is there a particular area of interest, such as children's health, the environment or education, that you would like your fund to always support? Or do you simply want to give back to your community and help address its greatest needs at any given time?

All of these goals are possible through a customized charitable fund created at the Community Foundation. If you can dream it, we can help you achieve it.

Permanent Endowment Funds

Donors who would like to create a permanent legacy for their charitable interests may establish an endowment fund. With endowment funds, principal is never spent. Instead, a portion of earnings becomes available each year, based on the Foundation's spending policy, for grants to the donor's specified charitable cause. Most endowment funds can be started with a minimum gift of \$15,000 (\$25,000 minimum to establish scholarship funds), and are a wonderful way to support your favorite organizations or interests, in your name, forever.

Pass Through Funds

Donors who want to streamline their current giving often establish a pass through fund at the Foundation. With an initial minimum gift of \$1,000, your fund may make grants of all or any part of the fund balance, at any time, to your favorite charitable causes. Many donors make additional contributions to their fund over time to sustain current giving. You keep track of only one tax receipt, but may make as many charitable gifts (minimum grant \$250) as you like from your single contribution. Pass through funds are an excellent way to take advantage of a windfall or bonus, or the need for an immediate income tax charitable deduction, and can help simplify your giving year-round.





Making Plans Now, For the Future

Bequest or beneficiary designation. Under these popular options — naming the Community Foundation in your will or trust or as a beneficiary on a life insurance policy or retirement account — you retain the use of your assets or property now while creating perpetual support for your favorite causes after your lifetime. You can change these plans until your death.

Charitable lead trust. This option allows you to create a trust to make annual income payments to the Foundation for several years to build your legacy fund. The balance of the trust is then distributed to your selected beneficiaries.

Give Now, Receive Income For Life

You can create your future legacy fund now by making a gift to the Foundation that provides income for you and/or others for life, then creates an endowment fund to fulfill your charitable objectives after your lifetime.

Charitable gift annuity. You receive a guaranteed, fixed annual payment for your lifetime in return for a present-day gift to the Foundation to create your future legacy fund. You may receive payments immediately or defer them into the future; for example, when you plan to retire.

Charitable remainder trust. You create a trust with your present-day or testamentary gift to the Foundation. The trust provides income to you and/or someone you name for life. Then, at the income beneficiary's death, the remainder of the trust creates your permanent legacy fund.

The Community Foundation of Southern Indiana does not provide tax, legal or financial advice. With any of these giving plans, there may be gift, estate or income tax implications, depending upon your personal financial situation. You should first consult with your tax, legal or financial advisor before making any charitable gift.

There are several ways to structure a legacy gift that allows you to create your future philanthropic plan now, while postponing the transfer of assets to the Community Foundation until after your lifetime.
