INVITATION TO BID

Notice is hereby given that the River Ridge Development Authority will receive sealed Bids regarding the 8th Street Phase 1 Reconstruction project at the Owner's office located at 6200 East Highway 62 Suite 600, Jeffersonville, Indiana 47130 until 2:00 p.m. (local time) on June 6, 2019. No late Bids will be accepted. Bids received by the allotted time will be opened and read aloud publicly.

DESCRIPTION OF WORK: The proposed roadway improvements will consist of construction of an extension of 8th Street from the existing Patrol Road intersection extending to the intersection with F Avenue, approximately 1,525 feet in the northern end River Ridge Commerce Center. The roadway will consist of 2-12' wide lanes and a 12' wide two-way left turn lane. The planned improvements will include curb and gutters, underdrains, a combination enclosed storm drainage system and ditches, sanitary sewer force main and an underground utility conduit. Also included in this project is the demolition of buildings 706-1, 706-1A, 706-1B and 706-1C, which are located at the intersection of 8th Street and F Avenue.

COMPLETION DATES: The work shall be substantially completed by November 8, 2019. Substantially complete shall mean that all asphalt paving, curb and gutter, storm sewer systems, sanitary sewer force main, seed and straw, sod and roadway signs are 100% completed. All work shall be 100% complete including the pavement markings, site cleanup, punch-list items, etc. on or before November 27, 2019. Additionally, the utility conduit installation shall be completed on or before August 9, 2019.

BID GUARANTY: Each Bid Proposal shall be accompanied by an acceptable Bid Bond in an amount not less than five percent of the total bid price executed by an incorporated surety company in good standing and qualified to do business in the State of Indiana.

Each Bid Proposal shall also require a statement to the effect that if the Bidder is awarded the Contract, Performance and Payment Bonds in an amount not less than one hundred percent of the total bid price will be executed by an incorporated surety company in good standing and qualified to do business in the State of Indiana.

BID PROPOSALS: Bid Proposals shall be properly and completely executed on forms incorporated in the Contract Documents, including State Form 52414 (Form 96), revised 2013 or later.

In accordance with IC 5-22-16.5, Contractors entering into a contract with the Owner will be required to provide an Indiana Iran Investment Certification.

In accordance with IC 4-13-18, Contractor shall submit an Employee Drug Testing Plan with their Bid and contractors of any tier as defined in IC 5-16-13-4 must comply with the drug testing requirements.

No Bidder may withdraw his proposal within a period of sixty (60) days following the date set for opening Bids. The Owner reserves the right to retain all Bids for a period of not more than sixty (60) days and said Bids shall remain in full force and effect during said time. The Owner further reserves the right to waive informalities, and to award the contract to any Bidder to the advantage of the Owner, or to reject all BIDS.
