## **INVITATION TO BID**

No late Bids will be accepted. Bids received by the allotted time will be opened and read aloud publicly.

DESCRIPTION OF WORK: This work shall include, but is not limited to, removal of existing pavement, widening of the existing roadway, milling and resurfacing of the existing roadway, underdrains, drainage culvert, erosion control measures, pavement marking and signs, and common excavation as specified to support development of the River Ridge Commerce Center in Clark County, Indiana.

COMPLETION DATES: The work shall be substantially completed by June 1, 2021. Substantially complete shall mean that all lanes of the road shall be completed and open to traffic through its final roadway surface, including shoulders, drainage features, markings, and signing as shown in the contract documents. All work shall be 100% complete including site cleanup, punch-list items, etc. on or before October 1, 2021.

Each Bid Proposal shall also require a statement to the effect that if the Bidder is awarded the Contract, Performance and Payment Bonds in an amount not less than one hundred percent of the total bid price will be executed by an incorporated surety company in good standing and qualified to do business in the State of Indiana.

BID PROPOSALS: Bid Proposals shall be properly and completely executed on forms incorporated in the Contract Documents, including State Form 52414 (Form 96), revised 2013 or later.
